The NCAA Division II East Coast Conference, the PAVO boards of the Nassau County Volleyball Officials Association and the Suffolk Board of Volleyball Officials are co-sponsoring this Seminar and certification clinic.

Upon completion of the three-step certification process, officials will be eligible to be hired as Lines Judges for East Coast Conference volleyball matches through the designated assignor. Officials will be assigned opportunities for rating and evaluation this spring. All participants must then take the 2010 Lines Judge exam with the date/time to be announced after June 1st, 2010. Those officials who have completed the three-part certification will have their names forwarded to the assignor for consideration. The certification will be effective for a year ending June 1, 2011. An agreed upon fee of \$ 75.00 per match will be in effect for all E.C.C. volleyball matches scheduled through the assignor.
